FBR-FBP 09042007	NATURAL GAS TRANSPORTATION AGREEMENT BETWEEN FROST BROTHERS RESOURCES, LLLP AND FROST BROTHERS PIPELINE, LLC WHEREAS: I. Frost Brothers Resources LLLP (FBR) needs Frost Brothers Pipeline LLC (FBP) to provide gathering, compression, and transmission service to the Energy Transfer Corporation (ETC) meter number 006899-00 produced from FBR wells. II. FBP has constructed or arranged for the construction of meter number 006899-00, a transmission line, a compressor station, and gathering lines, and provides services (the services) with these facilities to FBR. III. Twenty five cents (\$0.25) per MCF or twenty five cents (\$0.25) per MBTU is reasonable consideration for the services provided by FBP. IV. FBP has been providing these services for FBR since September-04-2007. NOW THEREFORE, IT IS AGREED AS FOLLOWS: I. FBP has provided and will provide gathering, compressing, dehydration, and transmission services to meter number 006899-00 on the Old Ocean Line. II. FBR will pay FBP twenty five cents (\$0.25) per MCF or twenty five cents (\$0.25) per MBTU for this service. III. FBR will owe interest on payables outstanding more than thirty (30) days of 6% per year simple interest. IV. INDEMNITY: FBP and FBR mutually agree to protect, defend, indemnify and hold harmless the other, their officers, directors, employees or their invitees, and any customer for whom either Company is performing services, from and against all claims, demands, and causes of action of every kind and character without limit and without regard to the cause or causes thereof or negligence of fault (active or passive) of any party or parties including the joint or concurrent negligence of either, any theory of strict liability and defect of premise, arising in connection herewith in favor of either s employees, subcontractors or their employees or invitees on account of bodily injury, death, or damage to property. V. The term of this agreement is one year. It will renew automatically from year to year unless sixty (60) days written notice is given. Either party can cancel with sixty (60) days written notice.

rate adjustment shall be dictated at will by Frost Brothers Pipeline, LLC with sixty days written notice.
