Such increase shall be made effective each January 1, commencing on January 1, 2019, and shall reflect the percentage increase (if any), rounded to the fourth digit after the decimal point, of change between (a) the seasonally unadjusted CPI for the calendar month that is four (4) months prior to the month in which the fee adjustment occurs, or if the unadjusted CPI is not available for such calendar month then for the most recently available calendar month, and (b) the seasonally unadjusted CPI-U for the same calendar month of the immediately preceding year; provided, however, each such fee or rate shall never be increased by more than 2.5% in any given year.
